Nomination Deadline – March 21, 2021
Please submit nominations in the ballot box in the foyer or online at <https://highwaychurch.net/board-nominations.php> (one submission per person)
- 2) Those nominated must have been an approved member of Highway Pentecostal Church for at least **one (1) year**. Only nominations submitted with names from the **“Qualifying Candidates”** list on page three (3) will be accepted.
- 3) All nominations must be signed to be accepted.
- 4) According to Church Policy, an individual must receive at least 5% of the total nominating ballots cast, for their name to be considered eligible for the Board. People nominated who have not received the necessary 5% or who are disqualified for other reasons are not contacted. At the nomination committees discretion those who otherwise qualify, but have less than 5% of nominations, may be contacted to fill the nomination slate.
- 5) All names will be prayerfully and scripturally considered by the Nominating Committee. The approved list of nominees for election will be sent out via email Thursday, April 1, 2021 and projected on the screen Sunday, April 4, 2021..
- 6) The following people have completed their term, Helen Edgley, Dale Todd, Ron Tremblay. All are eligible for nomination with Helen Edgley having served one (1) two (2) year term, Dale Todd having served one (1) three (3) year term and Ron Tremblay having served one (1) two(2) year term.
- 7) Please refrain from informing those you nominate. This is confidential information and subject to an approval process.
- 8) Our Annual Business Meeting will be held on Sunday, April 11, 2021 following the morning service.

2.2 CHURCH BOARD

2.2.1 QUALIFICATIONS

The qualifications for service on the board shall be determined and approved in accordance with the policy of this assembly, as guided by such scriptural provisions for deacons as are cited in Acts 6:3 and I Timothy 3:8-13. The official board shall be comprised of members who are of good report and sound judgment, examples to the congregation in matters of stewardship, church attendance, and spiritual maturity, and seeking constantly, as sanctified vessels, to be filled with the Holy Spirit (Acts 2:4; Ephesians 5:18).

As a member of the board, you assume the following responsibilities:

- ✓ *To be a faithful member of Highway Pentecostal Church.*
- ✓ *To be a faithful steward of time, talent, and financial means.*
- ✓ *To seek the Lord for divine guidance and courage to make decisions.*
- ✓ *To make decisions with wisdom, not emotion.*
- ✓ *To maintain an attitude of mutual respect and trust.*
- ✓ *To put the interests of the church above personal interests.*
- ✓ *To always remember the church's mission in making decisions.*
- ✓ *Support the board's decisions publicly.*
- ✓ *Maintain confidentiality and proper communication.*
